- This Invitation for Bids follows the General Procurement Notice (GPN Ref. No. AfDB266-02/19) for this
  project that appeared in UNDB online and AfDB website on 28th February 2019.
- The Government of Kenya has received financing from the African Development Bank in various currencies towards the cost of Nairobi Rivers Basin Rehabilitation and Restoration Program: Sewerage Improvement Project (PHASE II). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for Construction of Mwiki and Clay Works Reticulation Sewers.
- 3. The Athi Water Works Development Agency, the executing agency of the programme, now invites sealed bids from eligible bidders for the execution of the following works:
  - a. Laying of 120km reticulation sewers in Kasarani, Mwiki and Clay works areas of Nairobi
  - b. 6000 no. sewer household connections and
  - c. Construction of 2 No. Faecal Sludge handling facilities within Nairobi.
