The Athi Water Works Development Agency plans to implement the construction works for Rehabilitation and Expansion of Dandora Estate Waste Water Treatment Plant (**DESTP**) and intends to engage a consultant to provide Consulting Services for Design Review and Supervision of Works for Rehabilitation and Expansion of Dandora Estate Waste Water Treatment Plant

The scope of works for the Rehabilitation and Expansion of Dandora Estate Waste Water Treatment Plant project includes:

- **Rehabilitation of DESTP, inlet channels and waste water stabilization ponds**
- **Construction a 20,000m³/day waste water treatment system complete with Anaerobic ponds, facultative and maturation ponds**
- **Construction of a wetland**
- **Sewerage treatment auxiliary works**

The services of the Consultant shall consist of;

- **Review of Survey Works**
- **Review of Engineering Design prepared by AWWDA**
- **Supervision of construction Works to ensure works quality control and quality assurance**
- **Supervision of the implementation of ESMP**
- **Review and update the Resettlement Action Plan**
- **Management of Works Contract**
- **Review and Validate Payment Requests and Other Related Issues**
- **Review and Verify Completion Activities and Remedial Works**

The Athi Water Works Development Agency hereby invites consultants to express their interest in delivering the services described above.

Interested consultants must provide information with evidence that they are qualified and experienced to perform those services. For that purpose, documented evidence of recent and similar services shall be submitted.

Determination of the similarity of the experiences will be based on:

- **Experience in design review and supervision of waste water treatment contracts**
- **Experience in similar conditions.**
- **Availability of appropriate skills amongst staff including Project Manager, Resident Engineer, Waste Water Treatment Engineer, Geotechnical / Soils Engineer, Social and Environmental expert)**

Among the submitted applications, Athi Water Works Development Agency will shortlist a maximum of 6 consultants, to whom the Request for Proposals to carry out the services shall be sent.
