  - Certified copy of certificate of Incorporation and a valid Tax Compliance Certificate
  - · Audited Financial Statements for the last 3 years

Bids will be publicly opened in the presence of all bidders' designated representatives; ONLY ONE REPRESENTATIVE PER BIDDER will be allowed to attend at the address below 13th April, 2021at 10.05 a.m East African Time.
