1. This Invitation for Bids follows the General Procurement Notice (GPN) for this project that appeared in 28th February 2019 [Ref AfDB266-02/19].
2. The Government of Kenya has received financing from the African Development Bank in various currencies towards the cost of Nairobi Rivers Sewerage Improvement Program (PHASE II). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for Lot 4-Construction of East and West of Nairobi Reticulation Sewers.
3. The Athi Water Works Development Agency now invites sealed bids from eligible bidders for the execution of the following works:
 - a) Laying of 130 km Reticulation sewers in various areas of East and West of Nairobi, including, Karen, Uthiru, Kangemi, Ruaka, Mountain View, Westlands, Kilimani, Kileleshwa, Ngara, Eastleigh, Huruma, Mathare North and Utawala
 - b) Securing of Karen wastewater treatment plant and site ancillary works
 - c) 3000 Household sewer connections in East and West of Nairobi areas.
4. A Prebid meeting and Site Visit will take place on 28th April, 2021 starting at 09:00am (East African Time). The venue for the Pre-Bid site visit meeting will be at the Athi Water Works Development Agency Offices, Athi Water plaza, Muthaiga North Road, Off Kiambu road, Nairobi.

8. A 10 % Total Bid Amount margin of domestic preference **Shall** apply.
