- The consulting services ("the Services") involves undertaking Environmental & Social Compliance Audits for 5No ongoing projects. They include:
 - Construction Works for Rehabilitation of Dandora Estate Sewerage Treatment Plant (DESTP) (Lot 1). Construction of Kahawa West, Githurai 44 & 45 and Kahawa Sukari reticulation Sewers (Lot 2).

 - iii Construction of Mwiki & Clay works reticulation Sewers (Lot 3).
 - Construction of East and West of Nairobi reticulation Sewers (Lot 4). iv.
 - Construction Works for Extension of Water and Sewerage Intervention for Informal Settlements (Lot 5).
- The scope of services for the Consultant will include but will not be limited to: 2.
 - Review of the Bank's environmental and social policies' requirements,
 - Review of the applicable national legislations, regulations, norms, standards and procedures, including national legal Authorization, Permits and Certificates required prior to actions, Review of available reports on the project including the project appraisal reports, the Loan/grant ii
 - iii agreements, Environmental and Social Management Framework (ESMF) for the program, site specific environmental and social impact assessment reports, resettlement action plan reports, construction environmental and social management plans, the quarterly E&S Safeguards implementation and monitoring reports, any relevant documentation and records available and necessary for the assessment of the project E&S performance,
 - Determining and agreeing on the scope, methodology and specific set of criteria for the compliance audits with the AWWDA,
 - Evaluation of the actual capacity for managing and monitoring implementation of agreed mitigation measures and related E&S safeguards documents applicable to the project, v.

Holding consultation(s) with the relevant regulatory agencies and stakeholders on the status of the project with respect to identified E&S risks and impacts as well as planned and implemented mitigation measures as per the required legal permits and regulations as well as meeting international best practices as per the Multilateral Environmental Agreements,
 - Carrying out project site inspections to assess project implementation activities including management of contractors and related environmental and social risks and impacts. vii
 - viii. Carry out an analysis of the long-term project's environmental and social sustainability and recommend corrective measures required for long term sustainability.
 ix. Preparation of a comprehensive Environmental & Social Compliance Audit Reports.

 - Experience in preparing and/or managing the implementation of the Environmental and Social c) Impacts Assessment (ESIAs), Environmental and Social Management Plans (ESMPs), Environmental tal and Social Management Frameworks (ESMFs), Resettlement Action Plans (RAPs) of projects financed by AfDB or other DFI.
 - Experience in Occupational Health and Safety Audit of large infrastructure construction projects d) including water and sanitation.
