1.0 Introduction

All participants assembled at AWWDA Offices Board Room at 9:00am.

The meeting was chaired by Eng. Samuel Odhiambo of AWWDA who welcomed all participants to the Meeting. This was followed by self-introductions of all present.

In opening remarks by AWWDA, the Bidders' Representatives were informed that only issues requiring General Clarifications should be brought up during the Pre-Bid Meeting. Specific issues should be addressed in writing to the Employer as stipulated in the Bidding Documents, Volume I, Instructions to Bidders, Clause 7.1, no later than 14 days (i.e. by 26th April 2023) prior to the deadline for submission of bids (10th May 2023)

2.0 Brief on the Scope of Works

The Consultant, Artelia/MIBP, presented a Project Brief to the Bidders' Representatives detailing the Project Scope as follows:

- Construction of the Kabete-Olesereni Pipeline, DN 600 Ferrous (Steel or Ductile Iron) Pipeline, length 19.6km
- ii) Construction of Water Distribution Pipelines, HDPE and Ferrous (Steel or Ductile Iron) Pipeline, size 63mm to 600mm diameter, total length 37km in Kangemi, Kawangware, Wilson Airport area, Kabiria, Ngong Forest, Karen Plains and Kirigu areas
- iii) Water distribution network in Kinoo area, OD 50 60 OD 160, total length 20km
- iv) Construction of 1Nr. Reinforced Concrete Water Storage Tank at Karen, capacity 5,500m³
- v) Construction of Reticulation Sewers, OD 200 to OD 300 Double Wall Corrugated (DWC) HDPE Pipes, approximate total length 63km in Dagoretti, Ngando, Riruta, Kawangware, Kangemi and Uthiru areas.

 - Alignment of the Kabete-Olesereni Pipeline alignment (DN 600, 19.6km) from the start point within the Kabete Water Works to the end point near Olesereni Hotel
 - Alignment of the Wilson Main Line (DN 600, 4.2km) from the start point at Southern Bypass Langáta Road Interchange to the terminal end within Wilson Reservoir Site
 - Karen Reservoir Site
 - Riruta and Kabiria Project Areas (Water Distribution Pipelines and Sewers)
- Bidders' Representatives were advised to carry out comprehensive visits to all Project Areas and Sites
 on their own to thoroughly familiarize themselves with the Project Area and take note of any issues
 that may be relevant in the preparation of their bids including the proposed pipeline alignments, key
 features such as river and road crossings, geotechnical conditions, density of settlements and
 developments, access constraints, working space available and prevailing physical conditions in the
 different areas, etc.
